The medical administrative point person for all COVID related issues will be the Executive Director or, on the Director's absence, the Head Coach.

## Employee Safety

All employees and volunteers of the VYBA will first need to sign a medical release waiver (see in the Waivers section).

The following preventative actions will be in place to keep employees safe:

- A Non-Contact Infrared Thermometer will be used to scan each employee as they arrive for work each day.
  - o The temperature taker will be the Executive Director or the Head Coach.
  - o The temperature taker will wear personal protective equipment (PPE) when taking temperatures including a mouth/nose covering and medical gloves
  - o The temperature taker will not touch the employee. If the employee is touched, the temperature taker will change gloves immediately
  - o CDC Temperature cut-off is 100.3 deg F
- Employees will be told that they should not come to work if they feel sick or if anyone in their household has tested positive for COVID19 (this will also be stated in their signed waiver). Upon arriving each day, employees will be asked the following:
  - o Do you feel sick today?
  - o Have you had any of the following symptoms in the last 24 hrs: Shortness of breath (not severe), Cough, Chills, Muscle pain, Headache, Sore throat, loss of taste or smell
  - o Have you been around anyone sick in the last two weeks?
- If an employee answers yes to any of the above questions, and/or has a fever of 100.4F or greater, they will be isolated and sent home. An incident report will be filled out. Any surfaces they may have touched will be disinfected.
- If an employee begins to feel sick while at work they will immediately tell the Executive Director or Head Coach and isolate themselves until they can leave the facility. Sailing sessions will be ended for the day and guardians will be called and informed of the situation. The facility will be deep cleaned for opening the next day.
- No medical records will be kept for normal temperature readings, only for fever readings. All fever incident reports fall under HIPPA laws and will not be disclosed except to the employee or guardian.
- An employee can return to work after 10 days of no symptoms or fever
- Timeclock punch will be disinfected between each punch in or out. The employee can also choose to use the mobile app to sign in and out on their phone, which will be the encouraged and preferred method.

## Coach Boat and Radio

- Coaches will try to keep 6' distance while on boats, but must wear a buff on their mouth or nose (or other covering) if not able to maintain the distance.

- One radio will be assigned to each coach each day. Only one user per radio will be allowed. Radios will be disinfected after each session before charging.
- If rescue is required, PPE gloves should be used when touching any sailor. Coach must wear buff or face covering during the rescue
- If a coach accidentally goes in the water or must go in the water, face coverings should be removed to avoid drowning hazards

## Rescue

According to recommendations by the Red Cross, if CPR is needed, **Instructors will NOT perform any mouth to mouth procedures, but can perform hands only compressions until professionals arrive.** For any minor medical issues such as scrapes, splinters, etc, Instructors will wear face covering and gloves and will provide first aid provisions to the sailor for them to treat themselves if possible. If assistance is needed, gloves and face covering will be worn by instructor and sailor while treating the issue. Gloves will be immediately discarded and hands washed according to CDC guidance.

## Cleaning and Disinfecting

At the end of each morning and afternoon session, all high touch points will be cleaned with a bleach based cleaner or environmentally safe viralcide soap and water. These areas include but are not limited to:

- Coach boat driving mechanisms
  - Radios
  - Tillers
  - Main Sheet / Jib Sheet and other controls
  - Sprit poles
  - Hoses and sprayers
  - Tools
  - Classroom chairs
  - Tables and counters
- Employees will use the Yacht Club Marina restrooms and will wash their hands before sessions begin and frequently during sessions. The Venice Yacht Club safe operations protocol can be found [HERE](#) .
  - Hand sanitizer will be provided for employees and sailors' use.

## PPE

- Employees should provide their own face coverings. Buffs will be acceptable. All face covering should be washed each evening. If employees do not have face coverings, VYBA will provide buffs for purchase at a small cost.
- Medical gloves will be provided in the Shed first aid as well as in coach boat waterproof boxes

## Food / Water

- Employees should bring enough water for the day in their personal water bottles.
- Employees will be required to bring their own lunch and should not share food.

## Sailor Safety and Protocol

The following minimum preventative measures will be taken to provide a safe environment for sailors. Instructors along with the Head Coach and Executive Director will be responsible for enforcing these measures.

### Registration Limits

- During restricted local orders, sailing session registrations will be limited to a total of 10 sailors and instructors in each skill group.
- During registration, parents are asked for any health issues of the sailor. VYBA reserves the right to refuse a sailor if they have autoimmune disease or any issues that would not allow them to social distance.

### Sign-in and Social Distance in the Facility

- Parents and guardians will receive all pre-session information including this policy before their session begins. Included in that email will be a virus specific waiver they will need to sign (see waiver section)
- Parents will be asked to stay in their car during drop off and pick-up except on the first day of check-in.
- Social Distancing and reminders about PPE will be in place on posters around the facility. Classroom chairs will be placed on marks on the floor 6' apart.
- Instructors will place sailors 6' apart when doing outdoor activities and marks will be placed on the docks and yards as reminders when appropriate. (example – survey flags or hula hoops used in the yard to mark appropriate distance when doing land drills)
- All VYBA garage roll-up doors will be open at all times to provide ventilation

### Personal Belongings

- All personal belongings **MUST** be taken home after each session. There will be no locker or cubby storage available after sessions
- All sailors must have their own personal life jacket (PFD) and must take it home with them after every session.
- All VYBA loaner life jackets will be disinfected before each session. When a sailor must use a VYBA life jacket, one jacket will be assigned.
- Cubbies can be used during the session with each child using the same cubby everyday. Cubbies will be disinfected after every session.
- Sailors will not be allowed to congregate around the cubbies.

## Bathrooms/Water/Food

- Only two sailors will be allowed in the restroom at any time. Additional restroom breaks will be provided for hand washing and restroom use as needed. Restrooms are part of the Venice Yacht Club Marina and are disinfected several times each day according to CDC and VYC requirements.
- No showers will be available for use
- NO WATER JUGS will be provided to refill water bottles. All Sailors will be required to bring enough water with them for their entire session. No water bottles will be refilled at the facility.
- Food cannot be shared and no snacks or food will be provided by VYBA.
- All snacks and lunches will be eaten outside with social distancing.

## Temperature Scan

In the medical waiver for sailors (attached), guardians will be asked for permission to take a sailor's temperature if the sailor is exhibiting symptoms or states they do not feel well.

- A Non-Contact Infrared Thermometer will be used to scan each sailor
  - o The temperature taker will be the Executive Director or the Head Coach.
  - o The temperature taker will wear personal protective equipment (PPE) when taking temperatures including a mouth/nose covering.
  - o CDC Temperature cut-off is 100.3 deg F for a fever
- Sailors and guardians will be told that they should not come to their session if they feel sick or if anyone in their household has tested positive for COVID19 or feels sick (this will also be stated in their signed waiver).
- If a sailor has a fever of 100.4F or greater, they will be isolated and sent home. An incident report will be filled out and classes will be cancelled for that day. The facility will be completely disinfected for reopening the following day.
- No medical records will be kept for normal temperature readings, only for fever or exhibiting COVID symptom readings. All Fever incident reports fall under HIPPA laws and will not be disclosed except to the guardian.

## Swim Test and Pool Use

- Yacht Club Pool will be used for swim tests. The pool follows state cleanliness and testing protocols.

## Equipment Rigging

Sailing typically involves group effort to rig and launch boats. VYBA will take extra precautions to make sure that very little group rigging will be done and when it is necessary protective facial covering will be worn by all involved.

To help prevent situation where social distancing is not possible, VYBA will do the following:

- When instructors and sailors must help launch a boat, both sailor and instructor will wear facial coverings if working within 6' of each other.
- A boat and will be assigned each day to one sailor for Opti/Pram/O'Pen BIC
- A boat will be assigned each day to two sailors for double handed 420s
- Once returning, sailors will be responsible for locating their specific dolly and derigging their boats. All boats, tillers, sails and lines will be washed with environmentally friendly soap and water by the sailor with assistance from instructor during washdown.
- Instructors will disinfect all high touch point areas and equipment as described above.
- Congregating inside the Shed will be limited

### Boat Occupancy

- Optimists, World Wide Prams and O'Pen Bics will have ONE sailor per boat unless a waiver is signed
- 420s will have two sailors per boat. Double handed boats will require that the two sailors:
  - o Sign a release
  - o Wear buffs or face coverings when not distancing
- Kayaks will have one rower per boat
- Paddleboards will have one rower per board

### PPE requirements

- All sailors will be required to wear a buff or cloth face covering when not able to keep a 6ft distance between them and other sailors and instructors
- Sailors are not required to wear face coverings when on the water unless in a double or multiple handed boats and can't distance
- All sailors will be required to have a buff or face covering to enter their session. Buffs will be available for purchase for a small fee if not brought to sessions.
- Sailors should NOT wear medical grade masks
- Medical gloves will be provided by VYBA when needed for first aid or when using high touch equipment
- It is recommended that each sailor bring their own full fingered sailing gloves and wash the gloves each night

### Sick Child Protocol and Reporting

If a child begins to feel sick with any COVID symptoms as described by the CDC, the child will immediately be isolated either through towing of the sailor and the boat back to the dock and isolation in an outside space, or by isolating outside with instruction observation.

- A temperature reading will be taken.
- Guardians will be called immediately to pick up the child.



- The sailor will remain in isolation until picked up.
- An incident report will be filed and subject to HIPPA laws will only be shared with the guardian.
- All employees and sailor families will be informed that there was a sick child at the session and asked to pick up their sailors. Classes will be cancelled for the rest of that day and facilities will be completely disinfected for the next day's session.
- The sailor will not be allowed to return to the session until 10 days after discovery of symptoms.
- If a sailor or anyone in the household of the sailor tests positive for COVID19, all employees and participants will be informed of the positive but not the identity of the sailor. VYBA will participate with a contact tracer if needed after a positive test and may provide attendance lists to the tracers on request.

## Regatta Protocol

For the Fall 2020 Race Season, VYBA will not participate in any regattas that require an overnight stay. All Regattas will be local day trips.

- VYBA is not responsible for car pooling. It is highly recommended that sailors only carpool with direct family or friends that have direct contact on a regular basis.
- Parents will not be able to congregate at the loading and unloading sites. Only staff and sailors will be able to load/unload and rig/derig boats. Parents that sign a virus waiver to help as a volunteer will be allowed in the area.
- Sailors will not be able to carpool with any staff of VYBA to events
- All parent volunteers for transport must sign a virus waiver.
- All parents and sailors must adhere to each regatta or series race virus policy.

Regattas hosted by VYBA will follow the [US Sailing Return to Competition Guidelines](#).

## Weather Provisions

Weather will be monitored 24 hrs in advance for possible situations that would keep sailors from being outside and in a more crowded space in the Shed

- If registration is less than 10, rainy day activities can safely be conducted in the shed with the proper social distancing to wait out short rain storms or light or too heavy wind.
- If registration is higher and 6ft social distancing of all sailors inside the shed is not possible, the Director may cancel daily session if winds sustained over 15knots for the full day or weather is not conducive to beginner sailing. Sessions will be canceled by 7pm the night before.
- If the weather is predicted to be severe or if the chance of rain is 80% or higher for the entirety of the daily session, the session can be canceled by 7pm the night before

## Media Response

All media and interview requests will be directed ONLY to the Executive Director. In the absence of the Executive Director, any requests should be forwarded to the Chair of the VYBA Board of Directors.

## Refund Policy

- If the session has already started, no refund will be issued for illness or any other reason per the [VYBA Refund policy](#)
- If the season is canceled because of government health orders, a prorated refund will be issued for missed remainder of the season.
- VYBA will make decisions on closures according to official orders and local health administrators. Sailing may continue even if Sarasota County schools close if deemed safe for outdoor activities to continue.
